

Raffle Bases
"EDiR Question of the day"

Base 1^a - Organizing Company

The EUROPEAN BOARD OF RADIOLOGY, S.L.U, is an Spanish company registered in the Commercial Registry of Barcelona in Volume 42942, Folio 119, Sheet B-420225, with N.I.F. B65668006 and registered office in Avinguda diagonal, 383, SA, 08008 Barcelona, Spain (hereinafter, the "**Organizing Company**"). The Organizing Company organizes a raffle (hereinafter the "**Raffle**") called "*EDiR Question of the day*", which is organized in two calls on a ratio of one call per day, from July 16 to 17 (both inclusive).

These terms and conditions contains the general rules and mechanisms to grant the transparency of the Raffle's proceeding (hereinafter, "**Bases**").

Base 2 - Requirements for participants

Any person over 18 years old and who has obtained the certificate recognizing his or her status of Radiologist, or who is in the last 2 (two) years of the training in the specialty of Radiology in his or her respective country, may participate in the Raffle (hereinafter, "**Participants**"). Employees of the Organizing Company, their immediate family members and/or any other person related to the organization and management of the Raffle shall be excluded from the same.

Base 3 – Scope of application

The Raffle is valid in all countries without exception. The promotion is carried out online by means of the following blog: <https://blog.myebr.org/>.

Base 4 - Requirements to participate in the Raffle.

In order to participate in the Raffle, participants must be certified radiologists or at least within the final two years of their national radiology training.

The participation in the Raffle is strictly personal, nominative and non-transferable.

The participation requirement is to send the online form established for this purpose, in which the Participant answer to the question proposed in the EBR Blog. Participants must complete the online form at the end of the process, in which they shall indicate their full name, email address and if they fulfill the participation requirements. Any information and data provided by the participants must be clear and unambiguous. Likewise, participants must agree to the processing of their personal data by EBR in order for the Organizing Company to manage their participation in the Raffle according to the privacy policy and data protection regulation. In case

any the above does not concur, the submitted participation form shall be considered null and invalid.

For their validity, these forms must be sent within the foreseen period of the Raffle, i.e. in the period elapsed between 8:30 a.m. and 1:30 p.m. of the day the question is posted on the Blog's website.

Any participation form that does not fulfill the conditions set forth in these Bases, which is illegible or that contains false or falsified information shall be considered null and void and therefore not be taken into account.

Base 5th – Awards

The Awards will be split in two (2) different calls, which are to be held in successive days (July 16 to 17, 2020). All three awards, individually, shall consist of the same prize:

- 1 EDiR exam spot, organized in 2021. EBR will not waive the examination fee nor will EBR support travel or accommodation. The Award has an economic value of 500euros.

Base 6 - Determination of winners and awarding of prizes

Raffle Terms:

The winners will be chosen by toss and among those who have correctly answered the Raffle's questionnaire.

The aforementioned toss will be performed by the Organizing Company by the procedures herein specified within the period starting once 30 minutes have elapsed since the end of the period granted for the forms' submission until 2:00 p.m. of the immediately following day.

Because of the immediate effect of the Raffle, neither the toss nor the final attribution of the three prizes shall be carried out with the assistance of any Notary public.

The Organizing Company reserves its right to conduct any required verifications on the identity, postal and/or electronic address of the participants, as well as on the certainty and honesty of their participation.

Raffle mechanism:

The mechanism of the Raffle is based on a computer program that performs the toss, that is randomly choosing the winner of the prize (hereinafter, "**First Winner**") among all the Participants who fulfill the requirements of the Second and Fourth Bases.

During the Raffle, a second winner will be elected (hereinafter "**Second Winner**"), by the means described in the previous paragraph, for in the event that the first winner did not accept the award within the period established in this Bases and the Raffle would not be deserted.

The identity of the winners of each Raffle's call shall be known and validated at 2:00 p.m. on the day immediately following such call and duly published in the aforementioned Blog.

The Organizing Company will contact the First Winner individually by email to the address indicated in the participation form.

If the First Winner does not reply to the aforementioned e-mail within a period of 14 days from the date of the dispatch of such email, it will be considered that he has renounced his award and this will remain the property of the Organizing Company, which must be offered to the Second Winner.

If the Second Winner does not express his or her acceptance within the established period, the Raffle shall be void, and its award shall become definitively the ownership of the Organizing Company.

Raffle Awards:

- 1st unit of the award: ONE (1) winner shall be drawn among all the participants in the Raffle published on July 16, 2020.
- 2nd unit of the award: ONE (1) winner shall be drawn among all the participants in the Raffle published on July 17, 2020.

Details of the awards:

Under any circumstances, shall the award of the Raffle be exchanged or compensated in cash, nor shall it be allowed any partial or total reimbursement in exchange for the award won by the winner.

The Participants are informed that the awards are nominative and non-transferable, thus their sale or transmission by any means is expressly prohibited.

The Organizing Company reserves its right to replace the awards stated in 5th Base with others of equivalent nature and value in particular circumstances that may require it, i.e. situations of force majeure.

Delivery of the awards:

Only one award shall be assigned per winner of the Raffle.

Prior to obtaining the corresponding award, winners must prove their identity to the Organizing Company, which shall correspond to the one indicated in the participation form. The Organizing Company reserves its right to request a copy of the identification document of the winners and to perform any verification it deems appropriate.

Winners must comply with these Bases. In the event that they do not fulfill the requirements of these Bases, the awards will not be delivered.

Base 7 - Publicity of the Bases

In order to ensure greater transparency and clarity of the Raffle, these Bases will be publicized on the website where the Blog is hosted.

In this sense, these Bases can be freely consulted in their entirety on the website www.myebr.org

In addition, these Bases shall be sent free of charge to any person who requests it in writing to the company by means of email.

Acceptance of the Bases:

Participation in the Raffle implies acceptance of these Bases in their entirety.

The breach of these Bases shall imply the automatic cancellation of the non-performing party 's participation and the impossibility of obtaining any award described in the 5th Base.

Base 8 – Data protection

In compliance with the Spanish Organic Law 3/2018, of December 5, (Data Protection Act, LOPD), the Spanish Law 34 / 2002, of July 11, on Services of the Information Society and on the Electronic Commerce (LSSI), and the Regulation (EU) 2016/679 of the European Parliament and of the Council, of 27 April 2016, on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, or GDPR), the Organising Company communicates its data protection policy to the Participants by means of its Privacy Policy.

The participation in the Raffle implies that participants shall complete a participation form in which they are required to provide the Organizing Company with their personal data.

Any personal data the participants provide the Organizing Company with shall be incorporated into the processing system of the Organizing Company. The Organising Company guarantees that all this personal data shall be treated confidentially and used to its legitimate purpose, in

the manner and within the limitations and complying with the rights that the Law provides the data subject with. Specifically, the data processing has de following purposes:

“In order to properly manage your participation in the Raffle, as well as managing the delivery of the award to the Raffle’s winners and sending advertising communications related to EBR and the Raffle award”.

In this way, and whenever they expressly consent, the Organizing Company sending of commercial communications electronically (email and / or SMS or MMS short messages) in accordance with the provisions of article 21.2 of the LSSI, regarding the products offered by EBR or the award of the Raffle. The Participants may object the processing of their data for promotional and commercial purposes by sending an email to administration@myebr.org.

This consent is granted without prejudice to all rights granted to participants by virtue of the aforementioned regulations and especially the possibility of exercising the rights of access, cancellation, rectification, opposition, limitation, deletion, portability of their rights, and revocation of any previously granted authorization without retroactive effects. Likewise, you have the right to file a complaint with your national relevant authority on data protection. The aforementioned rights may be exercised by sending an application letter by post or electronic means to the following address:

In the request, any data subject exercising his or her rights should include the following information:

- Name, surnames, a copy of the official ID card of the data subject;
- Specific request of the plea;
- Indication of the right/s that the data subject seeks to exercise;
- Personal Address for communications purposes.

The Organizing Company reserves the right to publish the name of the winners freely by any means of communication (internet included). The winner can oppose this communication with a simple request.

Base 9 – Limitation of liability

The Organizing Company is not responsible for the cancellation, delay or modification of the Raffle for force majeure reasons outside of the voluntary will of the Organizing Company. Any change in these Bases of the Raffle shall be published and dully informed to the Participants in accordance with the 7th Base above.

The Organizing Company is exempt from whatever responsibility for any unforeseen event, accident or incident, in relation with the award occurring once it has already been granted. The fiscal repercussions of the receiving of the prize shall be assumed by the winner. Therefore, the Organizing Company is relieved of any responsibility to that respect.

Base 10 – Applicable Law

These Bases will be governed by Spanish Law.

Any controversy resulting from the interpretation or fulfilment of the same will be submitted to the Law Courts of Barcelona, except in the case of a dispute with consumers that corresponds to the Judge or the Court of the consumer residence.
